Country Portfolio Evaluation Interview Guide

Date: September 5, 2012

This document presents the CPE standard guide for interviews with representatives from Government Agencies, GEF Agencies, Civil society and the GEF Small Grants Program.

The interview guide consists of a predetermined set of broad questions/topics for discussion during individual semi-structured interviews with key GEF stakeholders. The fairly open framework of general questions/topics presented here may be covered in a particular order depending on circumstances of the interview itself. This allows for focused, conversational, two-way communication.

These interview guides are structured in a way that allows cross-checking the perceptions collected from different stakeholders (i.e. the interviewees) with the evaluative evidence collected through other evaluation tools and methods during the CPE evaluative analysis phase. Interviews can provide reliable, comparable qualitative data, particularly when interviewing different categories of GEF stakeholders.

This guide allows for flexibility for the interviewer to follow leads and probe for more information. An analysis of the interview's results leads to more in depth exploration of the evaluation questions.

- In your opinion, what is the role of the GEF in your country?
- What is your experience with the GEF project design and implementation processes? What is your perception of the process?

- What is your perception of the GEF Secretariat and GEF Agencies (World Bank, UNDP, UNEP, etc.)?
 - How have GEF operations evolved since the beginning of involvement in your country?
 - What mechanisms are available for projects to learn from each other?

- How do government agencies learn?
- Are government officials involved in monitoring and evaluation?
 - o Barriers to involvement?
 - Role of independents?
- What is the government's impression of the GEF Resource Allocation Framework and the STAR¹?
 - What do you see as the advantages?

- I am a grantee and I am coming to you with a project idea, how could I get a SGP grant (take me through the project cycle process)?
- Project development how is advice given? When, who, how?
- How much time does it take for each step? What is the total time?
- What are the transaction costs for NGOs/CBOs?
- What are the main barriers for NGOs/CBOs for applying to SGP?
- Acceptance versus rejection rates? What criteria?

Relevance:

GEF Focal Area or Geographical Focus

- Focus/focal area priorities for SGP in the country How were these selected?
- Or Geographical focusing? And why?
 - What is the structure of the portfolio?
 - Which focal area has dominance and why? Measures taken to address this?

Relations with Focal Points and Conventions

- To what extent has the SGP involved GEF focal points in governance/oversight of SGP operations?
- What is the relationship between the SGP and Convention Reporting by the Government? (probe why?)
- How are focal points (GEF and Convention) involved in the SGP?

PR

• To what extent does the SGP contribute to GEF 'visibility' in the country? What are the main benefits of visibility?

Strategy, objectives and formulation

- What are the main country objectives? Vision or logic behind it or main assumptions behind the strategy?
 - o Poor and marginalized, why not focus on rich?
 - What is the process for putting together the strategy?
 - Who is involved and why?
 - Potential conflicts and tensions between stakeholders how are these resolved?

Links with GEF MSP – FSPs

• To what extent do the new SGP country strategies propose steps to link with FSP/ MSP country portfolio? If, so which project and why?

Conflicts and Tensions – Place holder for discussion on strategy/projects

- What have been the main tensions and conflicts among, local national and global priorities?
- Government attitude to local NGOs/CBOs positive/negative why?

Effectiveness

Results

- From your experience, what are the major *expected* results of the SGP?
 Or what is the potential based on working with communities?
 - What are the main SGP *expected* local capacity building results?
 - Individual/institutional?
 - Policy change/influence?
 - Knowledge/lesson-learning across the portfolio (and to MSP/FSPs)
- How and to what extent is the SGP *developing* approaches to produce environmental benefits?
 - Give examples?
- How has (*or will*) the SGP contributed to awareness raising and knowledge of global environmental issues?

Sustainability

- To what extent are the results of the SGP likely to be sustainable?
 - What are the factors that will contribute to sustainability (positive/negative)? Give examples.
- What are the main risks that could compromise sustainability of SGP projects?
 - Exit strategies? How?

Lesson learning – Replication/Scaling-Up

- How do you plan to disseminate project results down the road?
- How does the SGP address replication/scaling-up?
 - o Give examples of replication strategies foreseen factors necessary etc?
 - Examples of constraints?

Efficiency

General Information on Costs

- How much does it cost to administer the SGP?
- What are the main elements/line items of the costs?
 - What factors influence the SGP costs?

Co-financing

- To what extent has the SGP been able to leverage co-finance (in-kind or monetary)?
 - o Do you have strategy for raising co-finance?
 - From who?
 - Biggest contributor?
 - What are the main strengths and barriers in this area?
