## Where we are...

- GEF M&E capacity is considered to be of high quality M&E policy: "the paper fulfills all the good practice principles" (Global Accountability Report 2006)
- On paper, GEF scores 98 out of 100
  - One remaining issue: translating reports into more languages (Global Accountability Report 2006)
- Challenge is to achieve high quality in practice as well
- FY07 achievements: 3 process evaluations, 2 Country Portfolio evaluations, APR, Ethics & Terminal Evaluations guidelines, website and other publications
  - On-going: impact and 2 cross-cutting evaluations
  - Preparations for the international workshop




## The GEF Monitoring and Evaluation Policy

## **Essential elements**

- From studies to streams of evaluative evidence:
  - More in depth work, less reporting focus on high-level findings and issues relevant for Council
  - Annual reports on impact and country portfolio evaluations in addition to annual performance report
- Country Portfolio Evaluations:
  - Need to achieve reasonable coverage (GEF is active in 150 countries)
  - Relevant for RAF enables countries to interact better and improves relevance in both directions
- RAF review "special initiative" TOR to be presented in November meeting of Council
- All evaluations fully integrated into OPS4
