Overall Assessments and Ratings

Grant Objectives:

(i) to originate and implement several access expansion, intensification and renewable energy pilots with a view to provide inputs for the policy, legal, regulatory and institutional framework development process underway in Nigeria in the wake of the new Electricity legislation; (ii) Support the implementation of the National Renewable Energy Master Plan to reinforce its outcomes; (iii) develop market models for renewables, such as standard, bankable contractual agreement for grid-connected small hydro power and market penetration for solar PV technologies; and (iv) engender interest in development of energy-based cross sectoral development compacts (the Project).

Overall progress from 07/01/2011 to 06/30/2012 with regard to Achieving Grant Objectives:

Rating: Moderately Satisfactory (Previously Rated Satisfactory on 06/30/2011)

Comment:

The Grant Objectives have been achieved. The lower than satisfactory rating is mainly due to the fact that GEF-financed activities mostly focused on Technical Assistance, falling short on the procurement and installation of equipement by the grant as initially envisaged in the objectives. However, the TA activities carried out as part of the GEF activities, such as business models for off-grid solar at Mfaminyen Village and other rural grid and off-grid electrification models (Enugu, Cross-River and Imu) are becoming prototype for replication in other villages areas and have leverage the interest of local governments and NGOs operating the area. The ICR currently under preparation for the associated project, the Nigeria Electricity Development Project, will report in details on those activities (including GEF-financed activities).

Overall progress from 07/01/2011 to 06/30/2012 with regard to Implementation of Grant Financed Activities:

As mentioned above, implementation of the grant has been rated only MS due to the delays in procurement of goods for the implementation of some of the pilots, who in turns caused the low disbursement at the closing date (only about 20% of the total grant).

The grant aims to achieve its main objectives of access expansion, instensifcation and development of renewables through:
a) i) Demonstration of viable models for expansion of access to electricity through the implementation of pilot electrification projects in selected States so as: (i) to achieve lower distribution costs through improved technology; (ii) to intensify distribution in peri-urban areas; and (iii) to expand distribution to rural areas, including grid extensions and renewable energy development.

- (ii) Development of standard Power Purchase arrangements for Grid-connected small hydro projects, and development of replicable business delivery models for solar PV; and
- (b) Provision of support for the National Renewable Energy Master Plan and design of cross sectoral applications

The Work on Renewable and Rural electrification pilots have so far leveraged only minor amounts (The Government of Cross river is funding the operational expenses of the Solar village installation and is considering funding several additional village projects out of their budget in the future), outside the IDA and Government agreed Co-financing. However the nature of the pilots is such as the scaling up effects can be expected over time as the Rural electrification Agency becomes operational.
