OVERVIEW

Overall Assessments and Ratings

Grant Objectives:

The overall objective of the Project is to increase access of indigenous peoples to conservation funding with a view to improving their capacity in conserving their homelands and ultimately contribute to biodiversity conservation, in support of GEF-4 Biodiversity Objective 4: Catalyzing Sustainability or ProtectedArea Systems. More specifically, the objectives of the Grant are to:

- (i) Expand and strengthen the relationship between bio-conservation funders and indigenous peoples;
- (ii) Promote knowledge on indigenous peoples' best practices in stewardship programs; and
- (iii) Build capacity at the local level to advance indigenous peoples' conservation programs.

Overall progress from 07/01/2009 to 06/30/2010 with regard to Achieving Grant Objectives:

Rating: Satisfactory (Previously Rated Satisfactory on 06/30/2009)

Comment:

The project as achieved its objective. The first objective was to expand and strengthen the relationship between bioconservation funders and indigenous peoples. Through successful interactions with donors, that also participated in the round tables, IPs gained better trust with donors, and established partnerships that will be essential for sustainable conservation of biodiversity. The second objective was to promote knowledge on indigenous peoples best practices in stewardship programs. Through the four workshop held, practicioners and Indigenous peoples were able to meet, network and establish communities of proactice. First Peoples Worldwide ended each roundtable with an Empowerment Funding project. Roundtable participants were granted anywhere from \$15,000-\$25,000 and given the decision-making power to distribute the funds amongst themselves for activities related to improving access to donor funding. Most of the participants decided to split the funds evenly, allowing them to build relationships and trust for future collaboration. The third objective was to build capacity at the local level to advance indigenous people's conservation programs. IPs that participated in the workshops gained knowledge on how to improve grant applications which will increase their chances of applying and receiving grants. This will lower the costs of biodiversity conservation, as IPs are documented to conserve better and are more cost-effective than other outsider NGOS.

Overall progress from 07/01/2009 to 06/30/2010 with regard to Implementation of Grant Financed Activities:

Comment:

The project has carried out the main activities planned. The client conducted all research, and completed all four roundtables organized in Africa, Latin America, Pacific and Southeast Asia and Asia. The client#s final report included a set of practical guidelines to assist multilateral and bilateral foundations, and NGOs, particularly from developing countries, to use criteria that better meet their targets for funding Indigenous Peoples and to ensure true Indigenous participation in the design of conservation programs. The report also included an expanded knowledge base on funding availability and capacity building of Indigenous Peoples in biodiversity conservation projects and programs. Furthermore, the client produced a database of available conservation funding for IPs, which will be instrumental in determining appropriate funding options. All products delivered were of high quality.

Indigenous Peoples groups were connected regionally, and established networks of practice to be maintained through a discussion group on internet via the Indigenous Peoples Worldwide web site, a listsery, and sharing of information.

Grant follow-up and structure

Description and context of Grant:

The World Bank approved a revised Indigenous Peoples Policy (OP. 4.10) in July 2006. This policy is in effect in every country where the Bank makes investments. FPW project targeted Indigenous Peoples by including them in a consultation process to increase their capacity to access funding for biodiversity conservation. While this project is indirectly aligned with national

The project raised awareness and capacity of IPs to participate in conservation planning and access funding.

The guidebook offers IPs practical advice for improving access to conservation funding.

#A list of equivalent requirements for the conservation funding application process, reporting, and key indicators of program progress was also set as an indicator. The client provided an exit report complete with the above mentioned components, and recommendations for simplifying and improving the grant process for IPs. The client also compiled a database of all available conservation funding and the requirements for each grant, which is beneficial for IPs in searching for grant possibilities.

#At least 25 Indigenous communities represented at each of 4 regional consultations to discuss access to conservation funding was also an indicator when the project was prepared.- At each of the four roundtables, anywhere between 25 and 32 communities were represented in discussions.

#An active network of Indigenous Practitioners who participate in First Peoples discussion group on Indigenous Stewardship was set as the fourth and final indicator. This was clearly represented by the enthusiasm of attendees in the roundtables and the establishment of long-term informal networks. First Peoples Worldwide also agreed to maintain a discussion group on internet via the Indigenous Peoples Worldwide web site, a listsery, and to continue the sharing of information.
