

## Strategic Country Cluster Evaluation (SCCE): Least Developed Countries

## Selection of case study countries

January 2019

#### Introduction

- 1. Case studies are the main component of the LDCs SCCE. They focus on the overarching two evaluation objectives of (i) to provide a deeper understanding of the determinants of sustainability of the outcomes of GEF support in LDCs, and (ii) to assess the relevance and performance of GEF support towards LDCs' main environmental challenges from the countries' perspective.
- 2. Case studies and related countries have been selected by applying the following approach:
  - Step 1: Identification of main environmental challenges
  - Step 2: Linking main environmental challenges to individual countries
  - Step 3: Linking projects to countries' main environmental challenges and identifying change
  - Step 4: Grouping environmental challenges, projects and their change by region
  - Step 5: Selecting countries with most positive and negative change for country case studies
- 3. The focus is on completed projects for which annual performance review (APR) ratings are available, and which were completed between 2007 and 2014; the latter to provide sufficient time after completion allowing to observe the sustainability of change for these completed projects on the ground in the long term. Projects are classified as: (i) a combined outcome and likely sustainability rating resulting in a positive change, (ii) a combined outcome and likely sustainability rating resulting in a negative change, and (iii) a combined outcome and likely sustainability rating resulting in a neutral change (table 1).

4. In addition to the outcome and sustainability ratings, the selection of country case studies will be informed by trends over time of key environmental outcome indicators at geolocated project sites, with the aim of identifying cases of positive and absent or negative change.

#### Step 1: Identification of main environmental challenges

- 5. The selection process starts from an overview of the main environmental challenges faced by LDCs. Figure 1 below is derived from the overview of the main environmental challenges presented in table 1 of the approach paper (also annexed to this document). The figure synthesizes the 11 most commonly shared environmental challenges faced by LDCs.
- 6. The aim of the overview of environmental challenges per country is not to get a definite list of issues, but a literature reviewed, evidence-based assessment of countries main environmental challenges. It could be that countries make different choices in tackling priority issues for a variety of reasons, among others because there are conflicting priorities between environmental and socioeconomic motives, for political reasons, or because funding is available to tackle environmental issues that are not main environmental challenges.

#### Step 2: Linking main environmental challenges to countries

8. The second step in the selection process of case study countries links main environmental challenges to LDCs for each region. Since coverage of LDCs overlaps with the other two SCCE evaluations figure 2 categorizes LDCs by region and evaluation for a full picture of LDCs. Selection of case study countries for the LDC SCCE focuses on LDCs that are not covered by the African biomes and/or SIDS SCCEs.

9. Deforestation and land degradation are the most common environmental challenges identified by LDCs (39 LDCs and 16 LDCs not covered in the other SCCEs) followed by threats to biodiversity (29 and 12 respectively). Many LDCs also identified water related challenges including water quality and quantity (21 and 12), threats to marine resources (16 and 5), coastal and coral reef degradation (14 and 3), and threats to inland water resources (6 and 5).

#### Step 3: Linking projects to main environmental challenges

- 10. The third step is to find projects that are tackling these main environmental issues in the countries identified, with in the end positive, neutral or negative change on the topic. The focus is projects completed between 2007 and 2014, the latter to provide sufficient time after completion allowing to observe the sustainability of outcomes for these completed projects on the ground in the long term. There are 127 projects in this cohort, 106 of which have APR ratings and complete project documentation. Of the projects with APR ratings, 75 are national projects and 31 are regional projects.
- 11. The projects' outcome and sustainability ratings are translated into an expected positive, neutral or negative change according to the matrix in table 2, translating into the ratings distribution in table 1 and the project overview in figure 3.

- 12. This change is used to further inform the country selection and case study groupings and will be verified on location, keeping in mind that all projects have closed at least four years ago and the sustainability at completion might have changed since then—either for better or for worse.
- 13. Figure 3 gives an overview of projects by environmental challenge and region, with their change rating being either positive or negative. A list of projects by environmental challenge and ratings is also presented in annex 1.

Figure 3: Linking projects to main environmental challenges




Figure 3: Linking projects to main environmental challenges (continued)





Figure 3: Linking projects to main environmental challenges (continued)





#### Step 5: Country case study development

- 14. The final step focuses on LDCs that are not covered by the African biomes and/or SIDS SCCEs. Guided by the mapping of countries and projects to environmental challenges (figure 3), countries with the largest number of national and regional projects with positive and negative ratings are selected. The countries selected also include those in which projects addressed the most commonly shared environmental challenges, i.e. deforestation and land degradation, threats to biodiversity, desertification, threats to in-land water resources, and threats to coastal and marine water resources. Other environmental challenges will be covered as opportunities for data gathering in the countries selected arise.
- 15. Five countries result from the application of the above criteria: Mozambique and Tanzania in Africa, and Bangladesh, Bhutan, and Cambodia in Asia. Table 3 lists positive and negative projects in each country by environmental challenge.
